

Upson books higher income, revenues for 2022

MANILA, Philippines – Upson International Corp. (UPSON), a newly listed firm and the country's largest retailer of personal computers (PCs) and information technology (IT) products, has booked higher income and revenues for 2022.

Based on the company's annual financial statements of December 31, 2022, Upson booked a net income of P537.86 million, or 33.25 percent higher than the P403.64 million net income booked in the same period in 2021.

At the same time, the company's revenues rose by 10.38 percent to P9.46 billion in 2022 from P8.57 billion recorded in 2021.

UPSON is a retail company that operates several retail outlets such as Octagon Computer Superstore, Micro Valley, Gadget King, as well as concept and specialty stores like Acer, HP, Brother, Silvertec and Octagon Mobile in select locations.

As of December 2022, UPSON operates 207 branches nationwide and a total of six warehouses, located in Manila, Cebu, Cagayan De Oro, and Davao City.
