Background/Description of the Disclosure

Pursuant to the directive of the Securities and Exchange Commission ("SEC"), we write to inform the Exchange that we received today the letter of the Market and Securities Regulation Department of the SEC ("SEC MSRD") dated May 2, 2025 advising Upson International Corp. (the "Company") that the SEC MSRD has granted the requests of the Company for exemptive relief from the requirement under Rule 68 of the Revised Securities Regulation Code ("Revised SRC Rule 68") that the interim financial statements of the Company for the first quarter of 2025 (the "2025 Q1 Reports") be attached to the Definitive Information Statement (the "DIS") for its 2025 Annual Stockholders' Meeting scheduled on May 26, 2025 and the release of the DIS without the 2025 Q1 Reports.

The SEC MSRD found merit in the justification of the Company that the 2025 Q1 Reports would not yet be available by the time of the filing of the DIS and the mandated dissemination of the DIS by May 5, 2025 since the 2025 Q1 Reports are still scheduled to be reviewed by the Board Audit Committee and presented to the Board of Directors at their regular meetings scheduled on May 8, 2025. The SEC MSRD also recognized that the deadline for the filing of the 2025 Q1 Reports is on May 15, 2025 and the Company was obliged to apply for exemption to ensure that it would not violate applicable laws and rules and it would be able to distribute the DIS within the period required by its By-laws, the Implementing Rules and Regulations of the Securities Regulation Code, and its Manual of Corporate Governance. The Company was however advised that a request for a similar exemptive relief for any future annual stockholders' meeting will no longer be granted and was reminded to comply with the requirements of Revised SRC Rule 68.
